China's crop protection industry is thriving and ready for more advanced technology, higher quality crop protection products, and more investment. China is relatively weak in these areas and is prepared to work harder. Ninety-five percent of domestic crop protection products manufacturers are small-scale and have lagging technology and additionally, are not keeping up strong profits.

China is largely an agricultural country with diseases and insects negatively affecting an area of 4,670 billion m² each year, and in recent years, its demand for crop protection products has increased by an AGR of 6%. Meanwhile, the policies that are being implemented strongly favor agriculture, and farmers are more willing to work on their land. Unfortunately, this also increases the demand for crop protection products. If demand continues at current speeds, it will exceed 340 kilotons by 2008.

Luckily, there are great commercial opportunities for crop protection products with high efficiency and low residue. Due to environment protection agencies and the determination of international conventions such as PIC, POPs and REACH, the Chinese government is helping to promote these safer crop protection products.

Meanwhile, the prohibition of 5 highly toxic crop protection products and the limiting of another 16 crop protection products in 2007 have lead to this new market valuing RMB \$10 billion for new crop protection products with these new specifications. Additionally, these insects and pests have built up resistance to many home-made crop protection products, including imidacloprid, chlorpyrifos and avermectins. This is helping the potential market for crop protection products much larger.

Furthermore, top-quality seeds and other bio-chemical technology is required to improve the quality of crop protection products and ensure the food safety. The 2008 Beijing Olympic Games will largely help promote high-quality crop protection products using the residue-free agricultural products.

Knowing companies' current dynamics and market situation will help facilitate searches for commercial opportunities in China's market. Also, a close following of government policies, natural disasters, and area dynamics will surely help any buyer make faster and smarter decisions.
