China's soaring ink industry

Promoted by the rapid development of Chinese economy and printing industry, China's ink industry has been growing amazingly in recent years, with compound annual growth rate (CAGR) of 15.51% from 2005 to 2007, and the growth rate is expected to maintain during 2008 to 2010. China produces about 400kt ink in 2007, and the output is predicted to amount to 600 kt in 2010.

As the fourth largest ink producer in the world, China's ink export is also increasing rapidly in recent years. Statistics from China Petroleum and Chemical Industry Association shows that China exported 49 kt inks in 2007, with CAGR of 27.8% from 2005 to 2007. It is known that the CAGR of China's ink will maintain over 20% before 2010.

Though the technology level and product quality in most Chinese ink producers are not so excellent as that of their global counterpart, some Chinese ink producers are making progress and their products now can compete with high performance imported inks. Moreover, China's ink production technology has been gradually improving with the effort of domestic ink producers and the entering of many foreign ink producers, who, attracted by China's promising ink market, have established their plants in China.

In order to snatch China's huge ink market, many foreign large scale ink manufacturers have constructed or are planning to construct new ink plants in China, such as Toyo Ink, DIC, Flint Group, T&K Toka, and etc.

The fast development of China ink industry is mainly promoted by Chinese prosperous economy and the thriving culture undertaking and construction. China has now been on its way to the fast urbanization, with the annual urbanization rate of 1% to 1.2%, as more publications are needed in cities than that in villages.

Besides, China's printing industry and papermaking industry,

as the two major ink downstream industries, or end use fields, have been growing rapidly in recent years, which greatly stimulates the growth of China's ink industry.

What's more, a large amount of ink will be needed with the approaching of several great events to be held in China, such as Beijing 2008 Olympic Games, World Expo Shanghai 2010 and the 16th Asia Games in Guangzhou in 2010 and so on, which all need a lot of ink in the advertisements and relative publications.

According to the solvent categories it uses, ink can be divided into water-based ink, UV ink, alcohol-soluble ink and solvent ink. Solvent ink has remained the major category in China for a long time, for its mature production technology. However, its share of consumption among all the inks categories is decreasing for the pollution it generates and the harm it brings to people. Alcohol-soluble ink now has been widely used in printing industry and its content of Volatile Organic Compounds (VOC) and toxic solvent are less than that solvent ink. Water-based ink and UV ink are eco-friendly ink categories, which almost release no VOC and toxic solvent, thus complying with the national environmental preservation policies. Their demand is increasing and they are expected to substitute solvent ink completely in the future.

Though China ink output has been expanding, there's still great market potential for special inks, such as electric ink, optical ink and anti-counterfeit ink, and so on, most of which need to be imported, as China is relatively weak in these aspects. What's more, China's demand for eco-friendly and special inks

is increasing year on year and such inks will be used more and more widely in printing industry.

Chinese ink manufacturers are looking forward to cooperation with overseas companies to exploit China's huge market. China's demand of environment friendly inks, inks with high performance and/or with special functions is increasing.
